Message from the Secretary General

This Financial Report provides an overview of the financial activities of the International Kempo Federation for the 2024 financial year.

During the reporting period, the Federation recorded total income of **EUR 246,130**, generated exclusively from membership fees paid by affiliated national federations and competition-related fees. Total expenditure for the year amounted to **EUR 221,375**, resulting in a surplus of **EUR 24,755**.

Financial administration was carried out in accordance with the Federation's Statutes and under the oversight of its competent governing bodies. The Federation did not receive public subsidies and was not subject to statutory external audit during the reporting period.

Throughout 2024, the Federation maintained adequate liquidity to meet its operational obligations and to support the continuity of its international activities.

Legal Status and Governance

The International Kempo Federation is constituted as a non-profit association governed by French Law (Loi 1901) and operates at international level in accordance with its Statutes.

The Federation's financial management is carried out within the framework established by its Statutes, internal regulations, and decisions adopted by its competent governing bodies.

This Financial Report has been prepared by the Federation's management and reviewed in accordance with internal governance procedures. The Federation is not subject to statutory external audit and does not receive public subsidies or government funding.

All financial activities of the Federation are conducted exclusively in support of its statutory objectives and international sporting activities.

Financial Highlights

During the 2024 financial year, the International Kempo Federation maintained a stable and balanced financial position while continuing to support its international sporting activities.

Total income for the year amounted to **EUR 246,130**, while total expenditure reached **EUR 221,375**, resulting in a positive financial result of **EUR 24,755**.

The Federation's income structure remained transparent and consistent, relying exclusively on membership and affiliation fees paid by national federations and competition-related fees. Expenditure was directed towards sporting activities, governance functions, and administrative operations in line with the Federation's statutory objectives.

The financial outcome for 2024 reflects prudent financial management and contributes to the Federation's ability to ensure continuity and stability of its international activities.

Income Overview

During the 2024 financial year, the income of the International Kempo Federation was generated exclusively from membership and affiliation fees paid by national member federations, as well as from competition-related fees linked to the organization of international events.

Membership and affiliation fees continued to represent a stable and predictable source of income, supporting the Federation's core governance and international operations.

Competition-related fees varied depending on the international competition calendar and the number of events organized during the year, reflecting the level of sporting activity undertaken by the Federation.

The International Kempo Federation did not receive public subsidies, sponsorship income, or government funding during the reporting period. All income was generated in accordance with the Federation's Statutes and applicable internal regulations.

Expenditure Overview

Expenditure incurred during the 2024 financial year was primarily related to the organization and coordination of international sporting activities, as well as to governance and administrative operations necessary for the effective functioning of the International Kempo Federation.

Sporting-related expenditure covered costs associated with international competitions, technical coordination, cooperation with event organizers, and activities linked to the Federation's international competition calendar.

Governance and administrative expenditure included statutory meetings, international coordination, communication activities, and general administrative functions carried out in accordance with the Federation's Statutes and internal regulations.

In addition, the International Kempo Federation paid annual membership and affiliation fees to relevant international sport and sport-related organizations, including TAFISA, ICSSPE, IAKS, and other comparable bodies. These memberships support the Federation's international recognition, cooperation, and alignment with global sport governance frameworks.

All expenditure was incurred in line with the Federation's statutory objectives and principles of prudent and responsible financial management.

Financial Position and Liquidity

At the end of the 2024 financial year, the International Kempo Federation maintained a stable financial position and sufficient liquidity to meet its ongoing operational obligations.

Financial resources were managed prudently to ensure the continuity of the Federation's international activities and the proper fulfillment of its statutory objectives.

Available funds and reserves were used exclusively to support operational continuity and international sporting activities. No financial resources were allocated to speculative or non-statutory purposes.

Anti-Doping Financial Independence

Anti-doping activities within the framework of International Kempo competitions are operationally delegated to competition organizers, in accordance with the Federation's regulations and applicable international anti-doping rules.

The International Kempo Federation does not directly manage anti-doping testing programs and does not exercise financial control over testing operations carried out by competition organizers.

No financial arrangements exist that could compromise the independence, objectivity, or integrity of anti-doping activities. The Federation's role is limited to regulatory oversight and coordination within its statutory framework.

Transparency and Ethical Principles

The International Kempo Federation is committed to principles of transparency, integrity, and ethical conduct in all its activities, including financial management.

Financial resources are managed responsibly and used exclusively in support of the Federation's statutory objectives. Governance oversight mechanisms and internal procedures are applied to ensure accountability and to prevent conflicts of interest.

The Federation promotes responsible governance practices and continuous improvement in line with international best practices for non-profit sport organizations.
